**ORDER**

On the recommendations of the Departmental Screening Committee constituted for grant of financial up-gradation under modified Assured Career Progression Scheme to the officials of the Rajya Sainik Board in accordance with instruction contained in O.M. No. 35034/3/2008-Estt (D) dated 19.05.2009 of Govt. of India, Ministry of Personal, Public Grievances and Pensions (Department of Personnel and Training), the Pr. Secretary (Revenue)/Divisional Commissioner, Delhi is pleased to accord approval of granting financial up-gradation to the following officials of the Rajya Sainik Board on completion of regular service of 10/20 years w.e.f. the date mentioned against each name:-

The officials concerned may be allowed to exercise their option, if any, under FR 22 (1)(a)(1) within one month of the issuance of the order granting the financial up-gradation under Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking in the event of over payment, which may be detected at a later stage the same will be recovered from their salaries.

The Head of the office is requested to ensure before issuing final order that 10/20 years of regular service or 10 years continuous in the same Grade Pay of the officials does not include the period of service rendered in State Govt./Statuary Body/Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (point No.10 of DOPT O.M. dated 19.05.2009)

The Head of the office is requested to issue formal orders for grant of the 1<sup>st</sup> financial upgradation in respect of the above mentioned officials working in their office. However, before the issuance of the formal orders the Head of office may again confirm that these officials have completed 10/20 years of regular service since the date of their initial appointment in the service or 10 years of regular service in the same Grade Pay and **are clear from Vigilance angle.**
