

They are further directed to report to their place of posting latest by 09/08/2012 failing which it will be presumed that she is not interested in joining the post to which she has been appointed and her appointment shall stand cancelled without any further communication. These appointments are temporary and subject to probation period for a period of two years and further subject to verification of character and antecedents by the DDE concerned. They have been medically examined by the concerned hospital and declared fit vide their individual report placed in their dossiers. These appointments are also subject to verification of documents/certificates including caste and Physically Handicap Certificate, by the concerned DDE on joining the school. The appointment of the candidate shall further be subject to outcome in O.A. 4478/2011 and in O.A. 4224/2011 and other court cases filed by the candidates who are senior to her in the merit and whose candidature has been cancelled by the Board (DSSSB).
