Sub:- Compliance of Guidelines for School Transport for the safety of children.

In continuation of the earlier guidelines issued vide order No. DE. 23(47)/School Br./2004/66942-66988 dated 18.11.2005 and No. F.DE/ACT/ 2011/2641-52, dated: 18.05.2011 on the subject cited above, attention of all the HOSs/Managers is hereby invited for strict compliance of guidelines issued by Hon'ble Supreme Court which have been duly incorporated in the above mentioned order dated 18.11.2005.

Further, the following guidelines should also be adhered to by the Heads of the Schools for transportation of children/students:-

- From 15th August, 2012 onwards, all the School Buses/Vans (Hired/Owned) should have Route Plans duly approved by the concerned HOS.
- From 1st October, 2012 onward, all the School Buses/Vans (Hired/Owned) should have a valid license holder Conductor.
- All the windows of School Buses/Vans (Hired/Owned) should be fully covered with minimum three grills having a maximum gap of 20 cm.

These instructions are also applicable to all sorts of transport facilities availed by the schools for ferrying school children for local excursions/sightseeing trips/Educational Trips and even for participating in various inter-school programmes/competitions and events etc.
