No.F.3(4)2009/F&S/P&C Whereas the Lt. Governor of the National Capital Territory of Delhi, in exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955(10 of 1955) read with the order issued by the Government of India. Department of Food Notification No G.S.R. 800 dated the 9th June, 1978 ordered vide No F.3(4)2002/F&S/P&C/141 dated 20-4-2009 that order No F 3(4)/2002/F&S/P&C (2)/19 dated the 20-6-2002 relating to Delhi Sugar Dealers Licensing order 1963 shall be kept in abeyance to the extent of the provisions of the Removal of (Licensing Requirements Stock Limits and Movement Restrictions) on Specified Foodstuffs (Amendment) Order 2009 for a period of four months from the date of issue of the said order or further order of Central Government whichever is earlier.

And whereas, the Central Government vide Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs) vide Notification S.O 1621 (E) dated 2nd July, 2009 has issued the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs (Fifth Amendment) Order 2009 and its clauses 2,3, and 4 provide as under:-

- The words and expressions used in respect of purchase, movement, sale, supply, distribution or storage for sale in the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs Order, 2002 shall be kept in abeyance for commodity, namely, Sugar for a period of six months i.e. upto 8-1-2010 from the date of commencement of this order.
- Nothing contained in this order shall affect the transport, distribution or disposal of sugar to places outside the state, nor shall it be applicable to import of this commodity:

Provided that the Central Government or State Governments may direct the importers to declare their receipts of stocks of sugar, and stocks retained by them.

All other provisions of the Removal of (Licensing Requirements, Stock limit and Movement Restrictions) on Specified Foodstuffs Order, 2002 shall continue to remain in force even during the period mentioned in clause 2 above."

Now, therefore, in exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with the order issued by the Government of India, Department of Food, Notification No G.S.R. 800 dated the 9th June, 1978 the Lt.
