ORDER

Whereas, M/s. Ichibaan Automobiles Pvt. Ltd., 602, Prabhat Kiran Building Rajender Place, New Delhi have been issued a license under Rent-a-Cab Scheme, 1989 and the same is valid upto 02/11/2012.

Whereas, a complaint dated 27.01.2012 received from Shri Pawan Sharma, Auto World Marketing wherein they have alleged that M/s. Ichibaan Automobiles Pvt. Ltd. have closed their operation from 602, Prabhat Kiran Building, Rajender Place, New Delhi and shifted to Mumbai.

Whereas, a Show Cause Notice issued vide this office letter 14.03.2012 as to why the license issued under rent-a-cab scheme cannot be suspended/ cancelled under the provisions of above mentioned Rent-a-Cab Scheme, 1989.

Whereas, authorized representative of M/s. Ichibaan Automobiles Pvt. Ltd. pleaded vide letter dated 14.03.2012 to condone their mistake that they did not inform shifting of their office to 6B/6 NEA, Old Rajindra Nagar, Delhi-110060.

Whereas, the said act was violation of clause (ii) of Paragraph 8 of Rent-a-Cab Scheme, 1989 and therefore a penalty of Rs.25,000/- imposed on the M/s.Ichibaan Automobiles Pvt. Ltd., license holder under Rent-a-Cab Scheme, 1989 and M/s.Ichibaan Automobiles Pvt. Ltd. paid the penalty.

Whereas, vide letter dated 27.03.2012 the authorized representative requested to cancel the Rent-a-Cab license on the grounds that they have closed their rent-a-cab operations in Delhi and submitted a copy of FIR regarding misplace of Rent-a-Cab License.

Therefore, I R. Ramanathan, Motor Licensing Officer, Taxi Unit, Burari being competent authority hereby cancel the license as per para 14 of Rent-a-Cab Scheme, 1989 issued to M/s.Ichibaan Automobiles Pvt. Ltd, under Rent-a-Cab Scheme, 1989.
