

| S.No. | Name of the Refresher Training Courses | Duration (in days) |
|-------|---|--------------------|
| 1 | Refresher Training Course for Drivers Badge (all P.S.V) | Two Days |
| 2 | Refresher Training Course for Conductors Licence Badge (all P.S.V) | Two Days |
| 3 | Refresher Training Course for driver's of commercial Vehicles (including HMV) | Two days |

Prescribed fee the each above said course is Rs. 400/- and in case of re-test Rs. 150/- only. However, the Evaluation test after the refresher training will be conducted at the respective institute in the presence of officer deputed by nearest zonal office to the respective institute. All the MLOs are directed to accept the computerized certificate issued by SHSWS.
