In this regard, I am directed to inform you that on analysis of Quarterly Report uploaded on the website of Central Information Commission, it has been observed that:-

1. No report has been uploaded by your department.

2. Report regarding 2<sup>nd</sup> and 3<sup>rd</sup> quarter is pending in respect of your department.

3. Report regarding 3<sup>rd</sup> quarter is pending in respect of your department.

It is pertinent to mention here that as per instructions issued by the CIC, the quarterly return will be due immediately after the completion of every quarter and will have to be uploaded on the website of CIC i.e. <a href="http://www.cic.gov.in">http://www.cic.gov.in</a> by the concerned department. "Online return can be submitted within 15 days after the completion of every quarter and after 15 days of the next quarter Public Authorities can submit their return online but their name will appear in 'LATE' list. Now, the fourth quarter of current financial year 2012-13 is also to be completed on 31.03.2013 and the return for the same is to be uploaded on the website of CIC on or before 15 April, 2013.

The CIC has conveyed the same vide D.O. Letter No. 19/1/2012-CIC-MoRe dated 15/01/2013 forwarding therewith a list of defaulting Public Authorities who have not yet uploaded their quarterly returns although three quarters have lapsed in the current year and informed that the quarterly returns for the three quarters for the year 2012-13 may be uploaded latest by 20th January, 2013.
