Subject: Instructions for the reply of Starred/ Un-Starred questions of Delhi Vidhan Sabha.


Nodal Officer will be responsible for getting the replies of Starred/Un-starred questions of Delhi Vidhan Sabha approved from the Head of Department.

He shall also ensure that 25 copies of the approved reply of Starred/Un-starred question are sent to Delhi Vidhan Sabha Old Sectt on the prescribed format by 3.00PM a day before the question is to be tabled in the session. He shall further ensure that 70 copies of the reply are also sent to Director, Information and Publicity, Old Sectt. on the day fixed for reply of Starred/Un-Starred question.

Nodal officer is responsible that if the question does not pertain to the Department of Food Safety, he shall immediately forward the said question to the concerned Secretary, to Minister, and Head of the Department under intimation to the Delhi Vidhan Sabha Sachivalaya.

As per the prevalent Parliamentary practice and directions of Hon'ble Speaker, Delhi Vidhan Sabha question will not be treated as transferred until the acceptance of the Department, where the question was transferred, was received in Delhi Vidhan Sabha Sachivalaya otherwise the Original Question receiving Department will be responsible.

Nodal Officer is also responsible to coordinate among concerned Departments if the question is related to more than one Department and make necessary arrangements for furnishing the reply to Delhi Legislative Assembly, within prescribed time, after receiving the requisite information from other Departments.
