ORDER

Under Annual Plan 2013-14, budget of Rs.2500 lakhs has been allocated under scheme OE (Plan). An Annual plan work out 2013-14 has been prepared in the Department (copy enclosed) wherein under the OE (Plan) scheme, Rs. 88 lakhs have been provided for training to be imparted to consumer organizations/street food vendors/FBOs.

As per the Scheme, the training is to be organized by each of the 11 Designated Officers in each district.

The administrative approval of competent authority for Rs.66 lakhs is hereby conveyed for the 11 districts @ Rs.6 lakhs per district for the remaining three quarters for the year 2013-14 which should be spent by the Designated Officers of the respective districts. Separate instructions for organizing training/awareness programmes have already been issued to all the 11 Designated Officers vide order NO.F.15(1)/DO/HQ/Trg./2013/3171-75 dated 29.7.2013.

The administrative approval is also accorded for Rs.22 lakhs allotted and placed at the disposal of DO(HQ) for organizing training/capacity building programme at state level for Department officers, FBOs, Apex trade/market associations and other stake holders

The Designated Officers are directed to conduct the training/awareness programmes as per the scheme. However, the expenditure will be done only after following the codal formalities as per the GFR . Documentary/videography shall also be made for each training/awareness programme and the same will be kept in records in concerned district.
