The permanent structure covers approximately 150 sq yards with one staircase of 116 to 120cm.

Remaining portion is open green, temporary shed, parking and road etc. No permanent sitting arrangement was seen at the time of inspection. The premise is approachable from Palla Bakhtawarpur main road of 60 feet.
