FIRE SAFETY CERTIFICATE

Certified that the M/s Krishan Gopal Gupta & Sons Fireworks located at Shop No.B-74 (ground floor), Central Market, Madangir, New Delhi of a building comprised of ground plus one upper floor was granted NOC by this department for (9 feet 3 inches X 15 feet i.e. 12.64 m²) floor area at ground floor vide letter No. F.5/(3A)/DFS/2006/256 dated 27-06-2006. The premises was re-inspected by the officer concerned of this department on 12-08-2013 in the presence of Mr. Neeraj Garg, owner of the fireworks shop and found that the building is comprised of ground plus three upper floors. The fireworks shop is running at ground floor and upper floors are lying vacant. The owner has added additional floor area of shop about 5.34 m², thus the total floor area of shop is now 9 feet 3 inches X 21 feet i.e. 17.98 m² and have deemed complied with the fire prevention and fire safety requirements in accordance with the guidelines issued by the Additional Commissioner of Police (Lic.) and the fireworks shop is fit for running the trade of Sale and possession of 1200 Kg Chinese / sparklers & 300 Kg Fireworks with effect from 02/08/13 for a period of **3(three)** years.

- f. Explosive Rules shall be strictly observed.
