The permanent structure covers approximately 100 sq yards on ground floor.

Remaining portion is open green, temporary shed, office, parking and road etc. No permanent sitting arrangement was seen at the time of inspection. The premise is approachable from National Highway No 1, main road of 60 feet. There was no electric over head wiring.
