In pursuance to DJB's Resolution No. 1710 dt. 09.09.2008 and Office Order No-307(Dist.) dt. 30.09.2008, the following vehicle drivers on contract basis who have been treated as M/Roll Beldar are, hereby, regularized/appointed as Beldar on temporary basis as per existing policy of regularization of M/Roll workers under the phased programme of 1997-1998, 1999-2000 and 2001-2002 against the vacant posts notionally from the dates mentioned against each in the Pay Band-I of Rs. 5200- 20200 with Grade Pay of Rs. 1800/- plus usual allowances as admissible under the rule and they are also allowed to get financial benefit w.e.f. 09.09.2008 i.e. the date of approval of the proposal by the Delhi Jal Board or the date of regularization which ever is later. Such regularized Beldars are also allowed to ply departmental vehicles with Risk Allowance @ Rs. 1000/- per month.
