Consequent upon the acceptance of offer of engagement to the post of Doctor (GDO) Grade-II on contractual basis initially for a period of 06 months or till the regular appointment on Doctors made by U.P.S.C. which ever is earlier with the remuneration of Rs. 25000/- p.m. (fixed) vide Memorandum No. DJB/AC(D)/Doctor/Contract/2012/132841 dated 06.12.2012 and further engagement vide Office Order No. 352 (Min.) dated 26.12.2012, Dr. Nidhi Bansal W/o Dr. Mudit Aggarwal has joined her duties in DJB on 04.01.2013 (F.N.).

She is further posted as Doctor (GDO) Grade-II on contractual basis at Chandrawal Water Works Dispensary against a vacant post. The terms & conditions of her engagement on contractual basis are as under:-

1. The engagement will not vest any right to claim for continued contractual engagement nor for regular appointment in Delhi Jal Board in any case of future.
2. The contract will automatically come to an end after the expiry of the stipulated period.
3. The contract can be terminated by the Department at any time without assigning any reason or notice.
4. Verification of original certificate of Educational qualification and experience.
5. The Department will not bear any kind of liability / responsibility during the period the candidate remains on contractual engagement with DJB except of payment of remuneration fixed by the department for per month for his / her service rendered to the department.
6. The candidate shall have to give one month notice or deposit an amount equal to one month remuneration if the candidate wishes to terminate the contract.
7. The department shall monitor his/her performance and depending upon his/her performance, his/her further continuation of contractual engagement. The decision of the Administration of DJB will be final in this case. His/her engagement on contract basis may be terminated at any time in case his/her performance / attitude is found unsatisfactory without any notice.
8. In case the candidate is already employed, the candidate should submit the NOC from the employer.
9. The candidate should not have been convicted in any Court of Law.
10. If any declaration / information furnished is found false or if any material / facts suppressed willfully, the contractual engagement will be terminated forthwith.
11. All the disputes will be dealt in the legal jurisdiction of Delhi only.
12. DJB will not hold any responsibility of incident / accident occurred to him / her during contractual engagement.

Dr. Nidhi Bansal W/o Dr. Mudit Aggarwal, Doctor (GDO) Grade-II on contractual basis will draw her remuneration from EE(E&M)-I.
