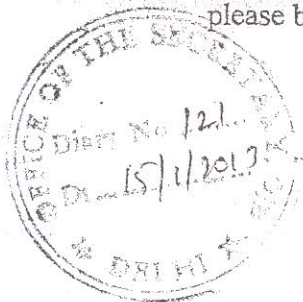

They should bring along with them the original Admission Ticket issued to them by A.R.Department for the said test and Identity Card of their respective department. Letter of Authority will not be entertained. It may also be informed that the Cash Awards will not be disbursed after 11/02/2013 so as to facilitate submission of final adjustment of accounts to the PAO. Further, requests/ correspondence in this regard will not be entertained.

It is further informed that the Cash Award and Merit Certificate to those candidates who have secured 70% and above marks in the test is to be distributed on 08th February, 2013 (Friday) at 3:00 PM in Conference Hall No. 2, 2nd Level, Delhi Secretariat, I.P.Estate, New Delhi-110002 in a function. As such the concerned candidates are requested to reach Delhi Sectt by 2.30 P.M. positively.
