Despite the comprehensive training to switch over the NPS in Delhi Jal Board and further issue of guidelines regarding vide Director(F&A) Circular dt- 31-12-12 & dt- 22-1-13, proper attention with sincere efforts to run the instant scheme timely in system, is not being paid by maximum of the officials/officers concerned reflecting their carelessness. To make it more convenient, auto run formula for calculation of rate of interest/contribution under NPS and other DATA has been made available in online system, hence, their should not be hindrance at any corner. However, to mitigate any problem, Sh.Narain Chakaraborthy, Sh.VinodK., Sh.Chandan C/o EDP Cell and Mr.A.K.Grover, AO(NPS) are providing their assistance physically as well as telephonically as & when is being required by any of the PAOs(AOs)/ AAOs/Dealing concerned.. Maximum divisional AAOs have not submitted the Legacy DATA up till now. This could cause unnecessary financial loss to the subscriber as well as department on a/c of interest on delayed initiation in this regard. Dir(F&A) has taken a serious view & has directed to give final opportunity to all concerned for submission of Legacy DATA & other required information without any further delay & excuse.

Besides, the Competent Authority has fixed a meeting at Conference/Retirement Hall Varunalaya Phase II, Jhandewalan at 9.30 AM on 11/2/2013 (Monday) for training to upload the Legacy Data in CRA online system.




