However, the entrustment of look after charge to the post of AO/ZRO is subject to the following conditions:

1. The entrustment of look after charge will be in their own pay scale of the post they are holding.
2. It will not confer any right on the officer to claim for ad-hoc/regular promotion to the post or any other service benefit.
3. The period of service rendered on look after charge basis will not count as officiating in the higher grade for any purpose.
4. The Competent Authority can terminate the interim arrangement at any time without assigning any reason and giving any prior notice.
5. Other conditions of service will be governed by the relevant rule and orders that may be in force from time to time.
6. This temporary stop-gap arrangement is made without prejudice to any court case.
7. The above official will also furnish an undertaking that they will not claim for any benefits of look after service in future.

Further, the above officers are directed to report to Director (A&P) for further posting.
