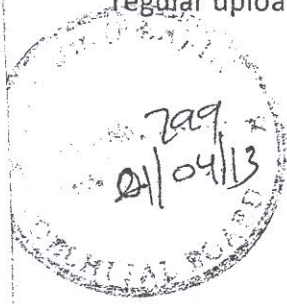

Subject: Non uploading of Subscriber Contribution Files (SCF) for last 3 months

Dear Sir

1. As per mandate of Government of India, PFRDA monitors the performance of NPS under various central accounting formations including Central Autonomous Bodies. As per the latest performance report received from NSDL/CRA, we observe that there are certain PAOs which have not uploaded any SCF during the three months i.e. November'12- Januray'13. Details of these PAOs are given at Annexure A.
2. Though the average subscribers in your organisation for the six months i.e. August 2012 to January 2013 is 1892, no subscriber had received credit in his PRAN which constitutes Zero subscriber coverage.
3. Efforts must be put in to upload NPS contributions on a monthly basis and also to achieve 100% of subscriber coverage in such uploads. NPS is a defined contribution pension scheme, where investment can only be made once the money is received into the system. Delay and indiscipline in uploading contributions create sub-optimal returns for the employee; adversely impact the corpus accumulation and consequently the pension receivable to them.
4. The action taken in this regard can be informed to us after uploading of pending SCFs and regular uploading of SCFs may be ensured to protect the interest of the subscribers henceforth.
