Consequent upon submission of acceptance for the post of Beldar on M/Roll on Compassionate Ground as per terms and conditions as contained in the Office Memorandum No. DJB/AC(G)-1/C.G./M.Roll/2013/D-1210 dated: 10/04/2013. Sh. Isbwar Dayal S/o Lt. Smt. Chameli Devi is hereby engaged as Beldar on M/Roll and posted with EE(North-West)-IV with immediate effect subject to following terms and conditions:-

1. He will be governed by the rules and regulations as applicable to the other M/Roll workers of D.J.B.
2. He will maintain the dependent/family of the deceased employee.
3. His engagement will further be subject to Verification of Educational and Cast Certificate and to the condition that nothing is found adverse about his character and antecedents, which will be got done by their DDO concerned within three months of his engagement. If any thing is found adverse about his character and past antecedents, his services shall liable to be terminated.
4. His engagement is further subject to the satisfactory work and conduct during the period of service.
5. He will not remain absent from duty for 30 days or more continuously, without prior approval of his controlling officer.
6. His pay will be fixed according to rules of M/Roll employees.
7. He will fit for the post as mentioned above. If, he found not fit for the post then his services are to be terminate without further notice.
8. In case of failure on any of the above counts, M/Roll engagement shall liable to be terminated without notice.

**Note:** - DDO concerned is also hereby directed to complete the following formalities:-

1. Check the original certificate of educational qualification and other certificate, if any before taking him on duty and thereafter get them verified within two months from the issuing authority.
2. Direct the individual to appear before the Medical Officer Incharge, DJB Model Town Dispensary, for Medical examination with in 60 days and send the photocopy of MOI report to the Admn.
