
The up-gradation is further subject to the following conditions:-

- (a) Pay & Allowances of the incumbents will be fixed under the provisions of FR-22 (1) a (1) subject to the terms & conditions contained in Circular NO.DJB/AC(W)/ACP/99/7377 dt. 30.11.99 and further clarification issued vide circular No. DJB/AC(W)/2000/29263 dt. 11.05.2000. The officials concerned may be allowed to exercise their options, if any, under FR-22 (1) a (1) within one month of issue of the order of granting the financial up-gradation under the ACP scheme.
- (b) At the time of fixation of pay of the above employees, the DDO shall again confirm that the concerned officials have completed at least 12 years of regular service with no promotion & 24 years of regular service with one promotion respectively .



- (c) The financial up-gradation is merely placement in immediate higher Pay Scale and does not amount to actual/functional promotion or seniority benefit etc.
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employee recommended for financial up-gradation was not under currency period of penalty on the date from which financial up-gradation has been recommended/ allowed to him.
