



As per present policy of Delhi Jal Board, an employee/Pensioner/Family Pensioner who is the member of Delhi Jal Board Medical Scheme can opt any two dispensaries for receiving medical treatment for themselves and their dependant family members.

There is a demand from the beneficiaries that they may be allowed to take treatment from any dispensary of their own choice.

The matter was examined and their demand has been found justified. The matter was put up before the Competent Authority who has agreed to dispense with the present restriction of opting only two dispensaries by a beneficiary and has ordered that the employees/ Pensioners/Family Pensioners including their dependant family members can receive medical treatment from any dispensary of their choice subject to the condition that once the treatment from a doctor has been started, the beneficiary shall have no liberty to change the doctor before completion of the period for which treatment has been prescribed in the first instance.


