Corrigendum

In partial modification of Office Order No. 68 dt. 11-6-12/14-6-12 issued by AC (L&E). The following corrections have been done which are as under:-

(A) Haider Pur Staff Qtr.

- (i) Serial No. 7 Type-III (Ground Floor) allottee. Garage charges may be treated as nil instead of Rs.30/-.
- (ii) Serial No. 7 Type- III (second & third floor) Revised rates of Licence fee w.e.f 1-7-10 may be read as Rs. 310/- instead of Rs.297/- plus Rs. 30/- as Garage Charges.

(B) Jal Vihar Staff Qtr.

- (i) The revised rates of Garage Charges in respect of Type-V(old)(Duplex) w.e.f. 1.7.2010 may be read as Rs.30/ per month.

- (ii) Serial no. 29 type-II Ground floor Qtr. rent w.e.f. 1.07.04 may be read as Rs 183/-, w.e.f. 01-07-2007 may be read as Rs. 185/-and w.e.f 01-07-2010 may be read as Rs.260/-
- (iii) Further No Garage Charges for Type-III Ground floor are to be levied/recovery.

Besides the above no Garage Charges are to be charged from Ground floor allottees of DJB Staff Qtrs.
