Delhi Jal Board has granted empanelment to various hospitals and Diagnostic Centers on the pattern of CGHS/DGHS for the purpose of providing medical treatment facility to the beneficiaries of Delhi Jal Board vide O.O. No. 12 dated 19.10.2011 subject to the condition that the empanelment will be for a period of two years or till the Hospital/Diagnostic Centers remain empanelled with CGHS/DGHS, whichever is earlier.

CGHS has de-panelled 07 hospitals from its list recently. Further Sitaram Bhartiya Institute of Science and Research has refused to provide medical treatment facilities to the beneficiaries of Delhi Jal Board on CGHS rates.

The matter was placed before the Competent Authority who vide his orders dated 08.07.2013 has de-panelled these hospitals from the list of authorized hospital of Delhi Jal Board with immediate effect. The list of these hospitals is enclosed as Annexure 'A'.
