INSTRUCTIONAL ORDER

Attention is invited toward this O.O.No. 34 dated 17.07.1990, vide which Safai Bhatta was granted to certain category of workmen and Office Order No. 129 dated 25.09.1995 vide which decision of the then DWS&SDC/Corporation was communicated regarding payment of dirt allowance to certain eligible category of workmen. (Copies enclosed).

Later on the policy of granting Safai Bhatta and Dirt Allowance was changed vide Office Order No.36 dated 26.12.2007 in which it was clarified that only one allowance i.e. either Safai Bhatta or Dirt Allowance shall be payable to eligible workmen as mentioned in the aforementioned Office Orders. In these orders, it was also mentioned that these allowance shall be payable only to those eligible workmen who come in Direct Touch with Sewage Dirt.

However, it has been brought to the notice of Administration that some workers of sewage side who are working in other divisions and are not in direct touch with sewage dirt are also being paid Safai Bhatta/Dirt Allowance.

It is once again clarified for the information of all concerned that Safai Bhatta/Dirt Allowance is payable only to those eligible workmen mentioned in the aforementioned orders who come in direct touch with sewage dirt and not related to designation.

This issues with the approval of the Competent Authority.

Previously, vide this office order no. 10 dt. 6.3.90 Safai Karamcharies (Drain Sweepers/Sewer Gang Beldars/Bhisties) working in the various divisions of the C.S.E. Department on the strength of this Undertaking were sanctioned Rs. 100/- p.m. as Safai Bhatta w.e.f. 1.6.89.

The Special Officer, exercising the powers of the DWS & SDC/Corpn. under section 19(2) (b) of the DMC Act, 1957 vide his notification no. 4836/GW/Corpn, dated 18.9.1995 has approved the increase/enhancement in the payment of Dirt Allowance from Rs. 5/- per month per workers to Rs. 100/- per month per worker to the following eligible Class-IV workmen of Sewage Bulk and C.S.E. side of the DWS & SDC Undertaking who came in direct touch with sewage, with IMMEDIATE EFFECT.

(W) Office orders no. 40 and 44 dated 16.3.90 and 17.1.90 respectively and only one allowance viz. Safai Bhatta or Dirt Allowance will henceforth be admissible.

The payment of enhancement in Dirt Allowance will be made from Salary Contingency Head. All concerned are requested to take action immediately.

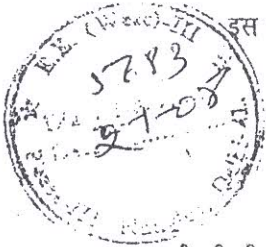
