The up-gradation is further subject to the following conditions:-

- (a) Pay & Allowance of the incumbents will be fixed under the provisions of FR-22(I) a (1) subject to the terms & conditions contained in DOPT O.M. No. 35034/3/2008- Estt. (D) dated 19-05-2009 respectively. The officials concerned may be allowed to exercise their options, if any, under FR-22 (I) a (1) within one month of the issue of the order, granting the financial up-gradation under the MACP scheme.
- (b) At the time of fixation of pay of the above employee, the DDO shall again confirm that the concerned officials either have completed 10/20/30 years of regular service or he has spent 10 years consituuously in the same grade pay for grant of benefit of 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup>/ financial up-gradation under MACP. Scheme without any break or unqualified service.
- (c) The financial up-gradation is merely placement in higher grade pay and this does not amount to functional/regular promotion or seniority benefit etc.
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.

(f) The DDO concern shall also ensure/verify that none of the employee recommended by DSC has been granted any in-situ or other financial up-gradation under ACP scheme/promotion respectively.

This issues with the approval of the Competent Authority.
