The up-gradation is further subject to the following conditions:-

(a) Pay & allowances of the incumbents will be fixed under the provision of FR-22(1) a (1) subject to the terms & condition contained in Director (A&P)'s Circular No. DJB/AC (W)/ACP/99/7377 dated 30.11.1999 and further clarified vide circular No. DJB/AC (W) 2000/29263 dated 11.5.2000. For ACP respectively. The officials concerned may be allowed to exercise their options, if any, under FR-22 (1) a (1) within one month of the issue of the order for granting the financial up-gradation under the ACP scheme.

- (b) At the time of fixation of pay of the above employee, the DDO shall again confirm that the concerned officials either have completed 12 or 24 years of regular service with no promotion for granting of 1st/2nd financial up-gradation respectively, since the date of initial appointment in their services.
- (c) The financial up-gradation is merely placement in higher pay scale and this does not amount to functional/regular promotion or seniority benefit etc.
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.
- (f) The DDO concern shall also ensure/verify that none of the employee recommended by DSC has been granted any in-situ or other financial up-gradation under ACP scheme/promotion respectively.
- (g) The DDO will verify that the employee recommended for financial up-gradation was not under currency period of penalty, on the date from which financial has been recommended to him.
