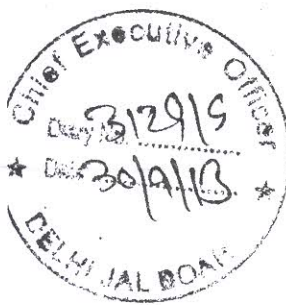

Sub:- Removal of advertisements displayed at government expense  
or in government premises.

The date for election to the Legislative Assembly of Delhi is likely to be announced by the Election Commission of India very soon. With the announcement of election date, the model code of conduct comes into force immediately. During the operation of model code of conduct, no advertisement can be displayed at government expenses. Besides this no government premise can be allowed to be used for advertisement.

You are requested to ensure that if any such advertisement is displayed, the same shall be removed immediately on announcement of elections and no advertisement is displayed or mounted thereafter. Similarly all advertisements on government premises shall be removed. Strict vigil is to be maintained to ensure that no such advertisement comes up during the operation of model code of conduct. The department must constitute a team to regularly inspect the premises of the department and remove any such advertisement. A Nodal Officer shall also be nominated by each department to deal with the issue.

You are requested to kindly take strict action on the above mentioned points and intimate the action taken along with the name of the Nodal Officer.
