The copy of verification report be sent to this office. In case, if the particulars of educational qualification and caste certificate of individual has already got verified by the DDO from the respective authorities, then there is no need to conduct fresh verification. Further, the original certificates of Educational qualification, proof of age, Caste Certificate, original Muster Roll Books and medical fitness report must be placed in PF&SB of the individual. The above appointment shall further subject to verification of attendance from original paid Muster Rolls of the individuals by the concerned AAO/AAOs.
