## OFFICE ORDER NO. 23

The Chief Executive Officer vide her orders dated 22.10.2013 has allowed the payment of Non-Productivity Linked Bonus (Ad -hoc Bonus) to the Muster-roll Workmen working in Delhi Jal Board for the financial year 2012-2013 in terms of Govt. of India, Ministry of Finance, Department of Expenditure's OM No.7/24/2007/E III (A) dated

- The Casual labour who have worked in offices following a six day week for at last 240 days for each year for 3 years or more (206 days in each year for 3 years or more in case of offices observing 5 days, week), will be eligible for this Non- PLB (Ad-doc Bonus) payment. The amount of Non-PLB (Ad-doc Bonus) payable will be ₹ 1200 X 30/30.4 i.e. ₹ 1184.21 (round off to ₹ 1184/-) in cases where the actual emoluments fall below ₹ 1200/- P.M. the amount will be calculated on actual monthly emoluments.
- 2 All payments under these orders will be rounded off to the nearest rupee.
- The clarificatory orders issued vide the Ministry's OM.No. F-14 (10)- E 3 Cood\88,dated 04.10.1988 as amended from time to time, would hold good.
- 4 The payment under these orders will be chargeable to the Sub-head "Salaries" in the relevant demand for grant of the organization concerned.
- 5 The expenditure incurred on account of Non-PLB (ad-doc bonus) is to meet from within the sanctioned budget provision of concerned Divisions/Offices for the current year.

All the concerned DDOs are, therefore, requested to kindly ensure the payment of ad-hoc bonus for the financial year 2012-2013 accordingly to the Muster Roll workers working under them immediately.
