Staff working at Varunalaya Complex may assemble in the open space between Varunalaya Phase-I and Phase-II at 10.50 A.M. on 28.10.2013 for taking the pledge at 11.00 A.M. Similarly, the pledge is to be administered to the members of the staff working outside Varunalaya Complex, by the respective senior most officers sitting in that complex i.e. CE/SE/EE/Dy.DOR/ZRO/ZE etc. at the aforesaid date and time.

2. Further, all Maintenance Zones should organize a meeting with the RWAs of their area wherein the EE concerned and ZROs may explain the grievance redressal mechanism. The EE concerned should act as the Nodal Officer.
3. All the Nodal Officers should depute a responsible subordinate official to collect Banners and posters from the Vigilance Branch between 21.10.2013 to 25.10.2013. These Banners / Posters are required to be displayed on the main gate of the building and should be visible to general public.
4. A compliance report may be furnished latest by 11.11.2013.
