**ORDER**

**09.01.2013:**

Present : Sh. Vijay Sheel, Appellant and Sh. Rajeev Kumar, Tehsildar(LAC)/APIO on behalf of SDM(Vasant Vihar).

Sh. Vijay Sheel r/o 238, Himgiri Apartments, Vikas Puri, New Delhi-18, had filed an RTI application dated 20.9.2012 before APIO/Tehsildar, Vasant Vihar, seeking information about various pieces of land in fields Nos:1147 &1148 as per latest Revenue Records of Village Rangpuri alongwith their measurement details and Record of Rights(Jamabandi).

Sh. Alok Sharma, SDM, Vasant Vihar/PIO vide his letter No. F.6/74/SDM/VV/ 2012/5628 dated 15.10.2012 had sent him a reply on the above issue .

Now, Sh. Vijay Sheel has further filed an appeal vide his letter dated 07.12.2012 , received in this office on 12.12.2012 before the undersigned/First Appellate Authority stating therein that the APIO has furnished an evasive reply and no enclosure has been received by him as stated in PIO's above reply.

In this regard an hearing opportunity was given to appellant to appear on 08.01.2013 at 2:30 p.m. with a copy to Sh. Alok Sharma, SDM, Vasant Vihar/PIO..

During the course of hearing, it was observed that PIO had sent him a reply vide his letter No. F.6/74/SDM/VV/2012/5628 dated 15.10.2012 but the appellant was not satisfied with this reply. The appellant further informed that he will be satisfied if a copy of Khatauni (containing 16 pages) and a copy of Record of Rights(Jamabandi) be provided to him for fields No.1147 & 1148.


Accordingly a copy of Khatuani ( containing 16 pages) was provided to the appellant during the course of hearing and it is further directed to PIO to provide the copy of Jamabandi(Record of Right) in this matter within 10 days, from the receipt of this order.
