**ORDER**

**19.03.2013:**

None present. Neither PIO/SDM(Vasant Vihar) appeared nor the appellent Sh R C Sharma appeared before the undersigned today.

Sh. R.C. Gupta, r/o F-130/7(G), Gautam Nagar, New Delhi-19 had filed an RTI application dated 13.12.2012 before PIO/SDM(HQ), which was further transferred vide letter No. F.11(1)/DC/ND/RTI(HQ)/2011/10648 dated 7.12.2012 to SDM(Vasant Vihar)/PIO for furnishing its reply to the applicant directly.

Sh. Alok Sharma, PIO/SDM(Vasant Vihar) did not provide him any reply, till the date of hearing first appeal before the undersigned i.e. upto 19.3.2013.

Sh. R C Gupta, now, therefore, has filed an appeal vide his letter dated 08.2.2013, before the undersigned/First Appellate Authority stating therein that he did not receive any reply so far from the PIO/SDM(VV) on his earlier RTI application dated 08.1.2013.

In this regard an hearing opportunity was given to appellent to appear on 19.03.2013 at 3:00 p.m. with a copy to Sh. Alok Sharma, SDM(Vasant Vihar)/PIO.

I have gone through facts of this case, the PIO/SDM(Vasant Vihar) is directed to be careful in future to dispose of the RTI application in a time bound manner as till date no information has been provided to the appellent. Furher, the information as sought by the appellent regarding details of compensation provided to Sarojini Nagar Bomb Blast Victims ( dt: 29.10.2005 at 6:30 p.m.) be provided to appellent within 15 days from the date of receipt of this order, as per records available in his office .
