ORDER

19.03.2013:

Present : Sh. S.K. Sharma, Appellant but SDM(Vasant Vihar)/PIO not present.

Sh. S.K. Sharma, r/o 118, Kishan Ganj Market, Old Rohtak Road, Kishan Ganj, Delhi-7 had filed an RTI application dated 08.01.2013 before PIO/SDM(Vasant Vihar) for seeking certain information about action taken on recovery reports.

Sh. Alok Sharma, PIO/SDM(Vasant Vihar) did not provide him any reply, till the date of filing first appeal before the undersigned i.e. upto 07.3.2013.

Sh. S.K. Sharma, now, therefore, has filed an appeal vide his letter dated 07.03.2013, before the undersigned/First Appellate Authority stating therein that he did not receive any reply so far from the PIO/SDM(VV) on his earlier RTI application dated 08.1.2013.

In this regard an hearing opportunity was given to appellant to appear on 19.03.2013 at 3:15 p.m. with a copy to Sh. Alok Sharma, SDM(Vasant Vihar)/PIO.

During the hearing Sh. S.K. Sharma, appellant reiterated this fact that he wants to obtain certain information about issue of recovery of amount from the office of SDM(Vasant Vihar)/PIO, as per copies of letters enclosed with his appeal.

The PIO/SDM(Vasant Vihar) is further directed to submit his explanation in writing, about the reasons for this delay in providing the information to appellant and the desired information be provided to the appellant within 15 days from the date of receipt of this order as per records available in their office . He will also ensure that in future, RTI applications are disposed of in a time bound manner

Appeal is disposed off accordingly.
