## ORDER

## 23.04.2013:

None present. Neither Sh. Parmod Singh, Appellant nor SDM(Vasant Vihar)/PIO appeared.

Sh. Parmod Singh S/o Sh. Devender Singh, r/o 15-A, Dhirpur, Near Nirankari Colony, Delhi-9 had filed an RTI application vide ID No.1126/SDM/VV dated 02.4.2013 before PIO/SDM(Vasant Vihar) for seeking certain information as per Revenue Records about Lal Dora and extended Lal dora Khasra(s) of Village Mahipalpur.

Sh. Alok Sharma, PIO/SDM(Vasant Vihar) replied to appellant vide his letter No. SDM/VV/PIO/2013/1326 dated 05.4.2013 stating threin that the applicant can inspect the relevant records of Village Mahipalpur on any working day and can get the desired information, as the appellant has not mentioned any specific khasra number.

Sh. Parmod Singh, now, therefore, has filed an appeal vide his letter dated 15.4..2013, before the undersigned/First Appellate Authority stating therein that he is not satisfied with the reply provided by PIO/SDM(Vasant Vihar) as he wants clearcut information about Lal Dora Khasra(s) and extended Lal Dora limits of Khasra(s) for Vill. Mahipalpur as per revenue records.

In this regard an hearing opportunity was given to appellant to appear on 23.4.2013 at 2:30 p.m. with a copy to Sh. Alok Sharma, SDM(Vasant Vihar)/PIO.

During the hearing the records of this case were called but none present with record. The information available with appeal of Sh. Parmod Singh reveals that he is not satisfied with the information provided to him by the PIO/SDM(Vasant Vihar) that which khasra(s) of Village Mahipalpur are covered under Lal Dora and which Khasra(s) under extended Lal Dora after chakbandi of said village?

In this connection the details of Khasra Numbers of Mahipalpur Village, after chakbandi and before urbanization be provided to appellant, as per information available in revenue records. In case this information is below 10 pages, the same can be provided free of cost and for each additional page appellant has to pay Rs.2/- per page.

The PIO/SDM(VV) is directed to provide the requiste information to appellant within 15 days from the date of receipt of this order at their end.

Appeal is disposed off accordingly.
