**ORDER**

**13.05.2013:**

None present. Neither Mrs. Yashoda, Appellant nor SDM(Vasant Vihar)/PIO appeared.

Mrs. Yashoda r/o S-99/199, Moti Lal Nehru Camp(JNU), Munirka, New Delhi-67 had filed an RTI application dated 26.3.2013 before PIO/SDM(Vasant Vihar) for seeking certain information about SC Certificate

No reply has been provided by Sh. Alok Sharma, PIO/SDM(Vasant Vihar) as on date of filing appeal i.e. 30.4.2013 to the appellant Mrs. Yashoda.

Mrs. Yashoda now, therefore, has filed an appeal vide her letter dated 30.4.2013, before the undersigned/First Appellate Authority stating therein that she did not receive any reply from PIO/SDM(Vasant Vihar) on this issue that if any family do not have any SC Certificate then Govt. proof of year 1951 is required.

In this regard an hearing opportunity was given to appellant to appear on 13.5..2013 at 2:30 p.m. with a copy to Sh. Alok Sharma, SDM(Vasant Vihar)/PIO.

During the hearing the records of this case were called but none present with record. The PIO/SDM(Vasant Vihar) is hereby directed to provide the necessary clarification to the appellant regarding any order requiring Govt proof of the year 1951 for applying SC Certificate.


The PIO/SDM(VV) is directed to provide the requisite information to appellant within 15 days from the date of receipt of this order at their end.
