13.5.2013:

None present. Neither Sh. Shyam Vir Singh, Appellant nor SDM(Vasant Vihar)/PIO appeared.

Sh. Shyam Vir Singh , resident of E-14, Saket, New Delhi-110 017 had filed an RTI application dated 19.3.2013 before SPIO/Tehsil Chankyapuri which was further transferred to SDM(Vasant Vihar) vide letter No. F.11(1)/DC/ND/RTI(HQ)/2011/78 dated 2.4.2013 by the SDM(HQ) for seeking certain information about timely updation of khasra khatuani of Village Rangpuri .

Sh. Shyam Vir Singh , now, therefore, has filed an appeal vide his letter dated 29.4.2013 received in this office on 3.5.2013 , before the undersigned/First.Appellate Authority stating therein that no reply has been provided by PIO to him so far.

In this regard an hearing opportunity was given to appellant to appear on 13.5..2013 at 2:30 p.m. with a copy to SDM(Vasant Vihar)/PIO.

During the course of hearing records of this case were called but none present with record. The PIO/SDM(Vasant Vihar) is hereby directed to provide the necessary information/ clarification to the appellant as per rules and guidelines under DLR Act for timely updation of khasra khatauni records of Village Rangpuri which still reflect the status of 1980-81 . It may also be intimated to the appellant that whether the revised khatauni of Village Rangpuri reflecting the status of 2004-05 is accessible to the Bhumidars or not , besides other information regarding review meetings for updation of such details and also ensure that all RTI applications be disposed of in a time bound manner in future.

The appellant has also requested to provide the information in question and answer form . This request of appellant cannot be accepted as the information cannot be devised or created for any applicant in a specially desired format as per provisions of RTI Act, 2005. However, if the information is available as per record it may be provided.

The PIO/SDM(VV) is further directed to provide the requisite information to appellants within 15 days from the date of receipt of this order at their end.

Appeal is disposed off accordingly.
