ORDER

11.7.2013:

Present Sh. Krishan Yadav on behalf of the appellant, PIO/SDM(VV) not present.

Sh. Vinit Kumar c/o M.s. S.K. Communications (Near Panchayat Ghar), Rajokri, New Delhi-38 had filed an RTI application dated 03.4.2013 before PIO/SDM(Vasant Vihar) seeking certain information about easementary rights.

Now, Sh. Vinit Kumar, has further filed an appeal vide his letter dated 15.6.2013 received in this office on 18.6.2013 before the undersigned/First Appellate Authority stating therein that he is not satisfied with the reply dated 21.5.2013 provided by SDM(Vasant Vihar)/PIO.

In this regard an hearing opportunity was given to appellant to appear on 11.7.2013 at 2:35 p.m. with a copy to Sh. Alok Sharma, SDM(VV)/PIO.

During the course of hearing the relevant case file related to this appeal matter was called by the undersigned and it has been observed that the appellant sought some clarification regarding Easement Act which is apparently not covered under the RTI Act being a document already available in public domain.

The PIO in his reply dated 21.5.2013 has mentioned that Fard in respect of Khasra No.825 is enclosed, which is not relevant to this case, at all.

If any details related to violation of easementary rights are available in any of office records, the same be provided to the appellant within 15 days from the date of receipt of this order at your end.

Appeal is disposed off accordingly.

In case the appellant is not satisfied with the information provided above, he can file 2nd appeal within 90 days at CIC at the following address :
