ORDER

11.7.2013:

Present the appellant Sh. Shyamlal Sharma , PIO/SDM(VV) not present.

Sh. Shyamlal Sharma s/o Late Sh Tara Chand, H No.54, Basant Nagar, Vasant Vihar, New Delhi -57 had filed an RTI application dated 22.5.2013 before PIO/SDM(Vasant Vihar) seeking certain information about Basant Gaon.

Now, Sh. Shyamlal Sharma, has further filed an appeal vide his letter dated nil received in this office on 27.6.2013 before the undersigned/First Appellate Authority stating therein that he did not any reply from the PIO so far

In this regard an hearing opportunity was given to appellant to appear on 11.7..2013 at 3:00 p.m. with a copy to Sh. Alok Sharma, SDM(VV)/PIO.

During the course of hearing the relevant case file of this appeal matter was called by the undersigned and it has been noticed that it is not clear that the appellant filed his RTI application before which PIO ?

In point No.2 of his RTI application the appellant has asked about total Rakba details of House No.5-A in Khasra No.33/10 with measurements.

In point no.3 the appellant has asked for total rukba details in respect of Khasra No.33/10 in which the name of Sh Shyam Sunder Sharma , H. No.4-A has been mentioned with all details of encroachments made in this khasra.

In this regard it is hereby ordered that demarcation report , if any, available in office record alongwith Tatima, Sizra and Field Book, as available on record related to above khasra be provided to the appellant within 10 days from the date of receipt of this order at their end so that he can get his desired information.


The SDM(VV)/PIO is also directed to explain the reasons, in writing , as to why the requisite information has not been provided to the appellant within stipulated time under the RTI Act .

Appeal is disposed off accordingly.
