**ORDER**

**16.7.2013:**

Present Sh. Harish Chaudhary , Appellant while PIO/SDM(Vasant Vihar) is not present.

Sh. Harish Chaudhary s/o Sh Megh Nath Chaudhary, H. No.27, Pili Kothi, Khan pur , MB Road, New Delhi-62 had filed an RTI application dated 20.5.2013 before Deputy Commissioner (New Delhi) which was further transferred to SDM(Vasant Vihar)/PIO vide their letter No.F.11(1)/DC/ND/RTI/(HQ)/2011/1826 dated 23.5.2013 for seeking certain information about details of land comprising in Khata Khatauni No.156 and 157 bearing Khasra No.620 min(3-12) and 627(4-16) at Village Ghitorni , New Delhi-30 . .

Now, Sh. Harish Chaudhary, has further filed an appeal vide his letter dated 2.7.2013 before the undersigned/First Appellate Authority stating therein that he did not receive any reply from the PIO/ SDM(VV) so far.



During the course of hearing the relevant case file related to this appeal matter was called by the undersigned and it has been directed that PIO/SDM(Vasant Vihar) should provide the relevant pointwise information to the appellant, as per records available in their office within 15 days of receipt of this order at their end. SDM(Vasant Vihar)/PIO is also further directed to show cause the reasons for not providing the requisite information to the appellant within stipulated time limit under the RTI Act, 2005.

.Appeal is disposed off accordingly.
