## ORDER

## 16.7.2013:

Present Sh. A.K. Sharma, Sub Registrar-VII/APIO and Sh. Ravinder Kumar, Appellant.

Sh. Ravinder Kumar r/o H. No. 464/10, Rampura, Delhi-35 had filed an RTI application dated 03.5.2013 before SDM(HQ)/PIO which was further transferred to APIO/Sub Registrar-VII vide their letter No.F.11(1)/DC/ND/RTI/(HQ)/2011/1303 dated 9.5.2013 for seeking certain information about mortgage of property bearing DDA MIG Flat No.280, 1st floor, pocket-1, Sector 23, Rohini, Delhi.

Now, Sh. Ravinder Kumar, has further filed an appeal vide his letter dated nil received in this office on 29.6.2013 before the undersigned/First Appellate Authority stating therein that he did not receive any reply from the concerned APIO/SR VII.

In this regard an hearing opportunity was accorded to appellant to appear on 16.7..2013 at 2:30 p.m. with a copy to Sh. A.K. Sharma, SR-VII/APIO..

During the course of hearing the relevant case file related to this appeal matter was called by the undersigned and it was submitted by the Sub Registrar-VII/APIO that it is not practically possible to provide the requisite information to the appellant as they do not maintain the records property-wise. He further submitted that the records are being maintained as per date-wise registrations only.

However, the undersigned is of the view that due to starting of computerization of data in office of Sub Registrar VII, now it has become so easy to trace out any property details. As such, Sub Registrar VII is directed to make earnest efforts in this regard and the requisite information can be provided to the appellant, if it is accessible through computerized data.within 15 days from receipt of this order at their end.

In case it is not available, then appellant is suggested to carry out inspection of desired records on any working day by fixing a prior appointment with APIO/SR VII over phone.

.Appeal is disposed off accordingly.

In case the appellant is not satisfied with the information provided above, he can file 2<sup>nd</sup> appeal within 90 days at CIC at the following address:
