**ORDER**

**18.7.2013:**

Present Sh. Hari Om, Tehsildar(HQ)/APIO, Sh. Rajbeer Singh, Dealing Asstt. , while Sh. Sudesh kr. Goyal , Appellant is not present.

Sh. Sudesh Kumar Goyal , A-35, Amar Nath Monga Block, Tis Hazari Courts, Delhi-54 had filed an RTI application dated 4.6.2013 before SDM(Chankya Puri) for seeking certain information about recovery details of NDMC in respect of various persons.

The APIO, Sh Hari Om has sent him a reply vide letter No. F.16(19)/DC/ND/Rec/2013/CH Puri/3066 dated 27.6.2013 . Now, Sh. Goel, has further filed an appeal vide his letter dated 3.7.2013 before the undersigned/First Appellate Authority stating therein that he is not satisfied with the reply of APIO.

In this regard an hearing opportunity was accorded to appellant to appear on 18.7..2013 at 2:30 p.m. with a copy to Sh. Hari Om, Tehsildar(HQ)/APIO.

During the course of hearing the relevant case file related to this appeal matter was called by the undersigned and it has been noticed that the relevant information is available in 07 different files, while the APIO has provided the information in compiled form to the appellant , which is available on record.

In case the appellant seeks any further information he can inspect these 07 files and take photocopies of his desired details after paying Rs.2/- per page, by fixing an prior appointment with APIO over phone on any working day between 2 to 5 p.m..

.Appeal is disposed off accordingly.

In case the appellant is not satisfied with the information provided above, he can file 2<sup>nd</sup> appeal within 90 days at CIC at the following address :
