**ORDER**

**30.7.2013:**

Present APIO, Sh. Hem Raj , Naib Tehsildar(LA) but the appellatant Sh. Vinod Pant, Advocate, not present.

Sh. Vinod Pant, Advocate r/o E-15 (Basement) c/o PVC Lockers, Lajpat Nagar-II, New delhi-24 had filed an RTI application dated 01.5.2013 before PIO/Land Acquisition Office seeking certain information about Award No.03/98-99 SW, year 1998-99. The APIO/NT(LA), Sh Hem Raj has sent him a reply vide letter No. F.1/ADM/LAC/ND/ID:841/2013/2872 dated 20.6.2013 covering all the 07 points.

Now, Sh. Vinod Pant, Advocate, has further filed an appeal vide his letter dated nil received in this office on 23.7.2013 before the undersigned/First Appellate Authority stating therein that he is not satisfied with the reply of APIO and copy of award is not found enclosed.

In this regard an hearing opportunity was given to appellatant to appear on 30.7.2013 at 2:30 p.m. with a copy to Sh. Hem Raj, NT(LA)/APIO.

During the course of hearing the relevant case file of this appeal matter was called by the undersigned and it has been observed that the APIO has furnished him detailed information on all the 07 points as sought by the appellatant in his RTI application . However, the APIO/NT(LA) is again directed to forward a copy of award No. 03/98-99 in respect of Village Rangpuri , which has not been received by the appellatant


However, if the appellatant wants any type of additional information , he may seek inspection of records related to aforesaid award , by fixing prior appointment with APIO/NT(LA) on any working day between 2 to 5 p.m.

The APIO/Naib Tehsildar(LA) is also directed to provide the requisite information to the appellatant as per records available in LAC Branch.

Appeal is disposed off accordingly.

In case the appellatant is not satisfied with the information provided above, he can file 2<sup>nd</sup> appeal within 90 days at CIC at the following address :
