ORDER

30.7.2013:

Present Sh. Narender Kumar , Appellant while PIO/SDM(Vasant Vihar) is not present.

Sh. Narender Kumar s/o Shri Khubi Ram, Vill and P.O. Kanhai, Near Old Auto Stand, Sector 45, Gurgaon -122 003 (hry) had filed 02 different RTI applications dated 17.6.2013 before SDM(Vasant Vihar)/PIO for seeking certain information about details of exact khasra numbers on which the building has been made with current property title as on 14.6.2013.

Now, Sh. Narender Kumar has further filed two appeals vide his letter(s) dated 22.7.2013 before the undersigned/First Appellate Authority stating therein that he did not receive any reply from the PIO/SDM(VV) so far.

In this regard an hearing opportunity was accorded to appellant to appear on 30.7..2013 at 2:30 p.m. with a copy to Sh. Alok Sharma , SDM(Vasant Vihar).

During the course of hearing the relevant case file related to both the appeals matters was called by the undersigned and it has been observed that the appellant seek details of owners and exact khasra numbers merely on the basis of photographs of two different properties enclosed with his RTI application. It has been informed to the appellant that it is not practically feasible for any PIO to give the desired information merely on the basis of photographs of building or parked vehicles on land . For this purpose appellant can ask the copies of Khatauni (for ownership details) and copies of sizra (for ascertaining khasra numbers in the map) .

However, the SDM(Vasant Vihar)/PIO is directed to provide the relevant information to the appellant, if it is available in any of his official records within 15 days from the date of receipt of this order at their end.

.Appeals are disposed off accordingly.

In case the appellant is not satisfied with the information provided above, he can file 2nd appeal within 90 days at CIC at the following address :
