ORDER

08.10.2013:

.Present Sh. Rajbeer Singh, Dealing Asstt. on behalf of APIO/ Sh. Hari Om, Tehsildar(HQ), while Appellant Sh. Sudesh Kumar Goyal not present.

This case was referred by Central Information Commission vide order No. CIC/DS/C/2013/ 000372 dated 20.9.2013 received in this office vide Dy. No. 19402 dated 30.9.2013 for the First Appellate Authority to enquire into the allegations made by complainant and pass appropriate order with a view that the desired information is provided to applicant at the earliest.

Accordingly an hearing opportunity was granted to appellant Sh Sudesh Kr. Goyal to appear on 08.10.2013 at 2:30 p.m. alongwith a copy to Sh. Hari Om/APIO , Tehsildar(HQ) to attend the hearing and submit his version on the allegations leveled by the appellant regarding non -providing the desired information.

During the course of hearing on 8.10.2013 at 2:30 p.m. Sh. Rajbeer Singh, Dealing Asstt. appeared before the undersigned on behalf of Sh Hari Om/APIO, Tehsildar(HQ) and submitted the reply of APIO that the APIO has already informed the appellant to inspect the relevant records of this case vide letter No. F.16(19)/DC ND/Rec/2013/3741-42 dated 17.7.2013 and get the desired photocopies of documents by paying @Rs.2/- per page, as the information sought by the appellant (related to 07 incumbents) is voluminous and is available in different small files containing 55-60 pages.

It appears that there is no malafide on the part of APIO as he offered the entire record which is available with him for inspection , but the appellant never turned up or tried to contact him. In this regard an order was also passed by the then First Appellate Authority/ADM(New Delhi) vide order No. 6619 dated 02.9.2013 intimating the appellant about the mobile number of APIO, Sh Hari Om for contacting him and fixing an appointment for inspection of documents .But the appellant rather than visiting this office has preferred to make a complaint at CIC level.




However, to facilitate the appellant in a better way, APIO, Sh Hari Om /Tehsildar(HQ) is hereby directed to provide all the photocopies of documents for these 07 persons to the appellant at free of cost at his given address within 10 days from the date of issue of this order

Appeal is disposed off accordingly.

In case the appellant is not satisfied with the information provided above, he can file 2<sup>nd</sup> appeal within 90 days at CIC at the following address :
