## 11.9.2013:

Present Sh. Raghunath Chauhan , Mahasachiv, Rashtriya Janadhikar Party,Office at: B-279, Kusumpur Village, Vasant Vihar, New Delhi, Appellant but SDM(VV)/PIO, Sh Alok Sharma not present.

Sh. Raghunath Chauhan, Mahasachiv, Rashtriya Janadhikar Party, B-279, Kusumpur Village, Vasant Vihar, New Delhi had filed 02 RTI applications dated 30.5.2013 and 5.6.2013 before SDM(Vasant Vihar)/PIO for seeking certain information(s) about violation of rights of poor people in making income certificates.

The SDM(VV)/PIO did not send any reply to the appellant so far hence two RTI appeals dated 4.8.2013 and 07.8.2013 respectively have been filed by the Appellant Sh. Raghunath Chauhan before the the ADM(New Delhi)/FAA. In the instant case we are dealing appeal dated 7.8.2013 filed by the appellant.

In this regard an hearing opportunity was accorded to appellant to appear on 11.9..2013 at 2:30 p.m. with a copy to Sh. Alok Sharma, SDM(VV) with the direction to attend the hearing with all relevant records of this case.

During the course of hearing the relevant case file related to this appeal matter was called by the undersigned and it has been noticed that the relevant information related to RTI application dated 30.5.2013 is related to various points related to office of SDM(Vasant Vihar). In point No.1 the appellant sought the action taken report from SDM(Vasant Vihar) on a specific complaint submitted by Diary No. 15062 dated 10.5.2013.

In point No. 4 the appellant has also asked about the office timings of SDM(Vasant Vihar), including lunch hours, which may be provided by PIO/SDM(Vasant Vihar) .

In point No.8 and 9, the appellant sought the details of documents which are required for applying a SC/ST certificate and Income Certificate(EWS) in office of SDM(Vasant Vihar with time limit of issuing such certificate. In this regard it is informed that this information is available on the official website of the department which is in public domain. However, the PIO is requested to provide the information to appellant as he informed that he does not have any internet /computer facility.

With reference to quries raised in point numbers 2,3,5,6,7,10,11,12,13,14,15 by the appellant, it is hereby informed that these queries are not apparently very specific, however, the PIO/SDM(Vasant Vihar) is directed to go through his RTI application of Sh. Chauhan and provide the information to the appellant which is available on record within 10 days of receipt of this order at their end. Appellant is also requested to inspect the relevant records as the information which he has sought is not apparently specific and in case the appellant wishes to inspect the records, the PIO/SDM(VV) has to allow the same.

The SDM(VV)/PIO is also directed to explain the reasons, in writing , as to why the requisite information has not been provided to the appellants within stipulated time under the RTI Act . He is also further directed to ensure that RTI information be provided to each applicant in a time bound manner as per mandate of the RTI Act, 2005

.Appeal dated 7.8.2013 is disposed off accordingly.

In case the appellant is not satisfied with the information provided above, he can file 2<sup>nd</sup> appeal within 90 days at CIC at the following address:
