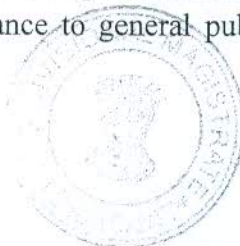
**CONDITIONAL ORDER**

By this conditional order I shall dispose off the Kalandra bearing DD No. 67 B dated 20.06.2013 received on 10.07.2013 from Police Station Sagar Pur against Sh. Lal Singh S/o Sh. Nand Lal for causing nuisance under section 133 Cr.P.C.

**Brief facts of the case are that-**A Kalandra bearing DD No. 67B dated 20.06.2013 received on 10.07.2013 in this office from Police Station – Sagar Pur, New Delhi under section – 133 of Cr.P.C alleging therein that Sh. Lal Singh S/o Sh. Nand Lal R/o RZ-61, Gali No-13/5, East Sagar Pur, New Delhi is running an illegal plastic toys factory without any safety measure and information / permission of civic agencies which is causing nuisance to the public/ residents.

Notices were issued to the accused. Accused was not present but the Inquiry Officer, Sh. Ram Phal, HC, Police Station Sagar Pur, New Delhi in the matter was present today. Inquiry Officer confirms that the activities are still going on causing nuisance to the general public. It was accepted by the accused that the area, where he is carrying the activities, is a residential area and such activities are not permissible in the area. However, he also claims that he is carrying out the assembling of plastic goods only and no manufacturing is carried out by him. However, the Inquiry Officer refuted his claim.

Now therefore, I Pradeep Kumar SDM (Delhi Cantt) hereby direct the accused, Sh. Lal Singh S/o Sh. Nand Lal to stop the activities being carried out at the aforesaid premises which is causing nuisance to general public as well as residents in the area.




Accused is further directed to show cause as to why this order be not made absolute on or before next date of hearing and to remain present on the said date.

Further, Assistant Commissioner, Factory Licensing department of West Delhi Municipal Corporation as well as S.H.O., Police Station Sagar Pur is also directed to ensure that the cause of public nuisance is removed forthwith. The compliance report will be submitted before next date of hearing.

Let a copy of this order may also be sent to Member Secretary, Delhi Pollution Control Committee for information and appropriate against the accused, if any, under relevant provisions of pollution laws.

Conditional order announced accordingly in the open court on this 26<sup>th</sup> day of August, 2013. Let the case to come up on 20.09.2013 at 3.00 PM for filing compliance of the directions as contained in this order by the accused and the concerned agencies.
