ORDER

31.10.2013:

Present Sh. Hem Raj, NT/LA/APIO and Sh. Surender Kumar, Patwari(LA) while Sh. Gaurav Malik, Appellant not appeared

On perusal of the RTI appeal dated 22.10.2013 filed by Sh. Gaurav Malik, it has been observed that the appellant has sought the information related to land acquired for widening of Mehrauli - Mahipalpur road, copy of survey report by the commissioner, land management, DDA, Vikas Sadan and DC(Vasant Vihar) alongwith details of land acquired of Masoodpur Village with their khasra Nos during 1939-40 vide notification No. 129 dated 24.12.1938.

The APIO/Sh. Hem Raj Submitted his reply vide email on 24.9.2013 to the appellant stating therein that no information is available in this office in respect of above points.

During the course of hearing Sh. Surender Kumar, Patwari (LA) also submitted in writing that no record is available in this office regarding widening of Mehrauli-Mahipalpur Road, Phase 1,2 and 3, including no minutes of meeting are available in this matter.

Moreover, the records sought by the appellant regarding Village Masoodpur is pertaining to year 1939-40, which is very old and is also not available with office.

Appeal is disposed off accordingly.
