ORDER

07.11.2013:

Present Sh. Jai Prakash on behalf of Sh. Sushil Kumar, (Appellant) and Sh. Isidor Kerketta, Dealing Asstt appeared on behalf of APIO, Sh. Hari Om, Tehsildar(HQ).

On perusal of the RTI appeal dated 12.9.2013 filed by Sh. Sushil Kumar, Asstt. Manager (ERP), Floor-11, Shipping Corp of India, 245, Madame Cama Road, Mumbai- 400 021. It has been observed that the appellant has sought the information from SDM(Ch.Puri)/PIO regarding verification of his own SC Certificate by attaching a photocopy of the same along with his RTI application.

On receipt of no information from the concerned PIO, within stipulated time, the appellant filed an RTI appeal vide his letter dated 24.10.2013, which was received in this office on 29.10.2013. Accordingly an hearing opportunity was given to appellant to appear on 7.11.2013 at 2:40 p.m. along with a copy to PIO/SDM(Ch.Puri) to attend the same.

During the course of hearing it was revealed that concerned APIO/Sh Hari Om, Tehsildar(HQ) vide his letter No.8708-09 dated 06.11.2013 has sent a reply to the appellant Sh. Sushil Kumar that the information sought by the applicant is very old and not available in this office. Sh. Isidor Kerketta, Dealing Asstt. also submitted that the office of New Delhi District came into existence in the year 1996-97 whereas the information sought by the appellant pertaining to year 1991 related to verification of a SC Certificate.

As the said information is not available in this office, the appellant is, therefore, suggested to contact the Office of Divisional Commissioner (HQ) at 5, Sham Nath Marg, Delhi-54 to ascertain the whereabouts of old records related to issuance of SC certificates.

.Appeal is disposed off accordingly.
