ORDER

07.11.2013:

Present Sh. Prashant Gupta on behalf of Sh. Shanti Swarup Gupta, (Appellant) and none appeared from the office of SDM(Vasant Vihar)/PIO.

On perusal of the RTI appeal dated 09.10.2013 filed by Sh. Shanti Swarup Gupta, 86 Natrajpuram, Kamla Nagar, Agra-282 005 (UP) it has been observed that the appellant has sought the information related to present status of various Khasra Numbers of Rangpuri Tehsil, Mehrauli, New Delhi. In this connection SDM(VV)/PIO has provided him a reply vide his letter No. SDM(VV)/2013-14/233 dated 10.9.2013 by enclosing copies of Khatauni(s) for these khasra numbers showing their latest status/details, as per records available in the office of PIO.


Now the appellant has filed an appeal dated 09.10.2013 before the undersigned stating therein that he want to know the details of "land-use" for the acquired land of these khasra numbers in Rangpuri Village and whether this work has so far been completed or not ?

During the course of hearing it was revealed that the concerned land was acquired for horticulture purposes and the details of the same can only be available with the department who is presently occupying this land about its "land- use" and completion of work . As no further information is maintained by this office after acquisition of land, the request of the appellant cannot be acceded to.

.Appeal is disposed off accordingly.
