The Official concerned may be allowed to exercise their options if any under FR22 within one month of the issuance of the order granting the financial up gradation under the Assured Progression Scheme/ Modified Assured Career Progression Scheme.

However, the grant of higher pay/grade pay is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Heads of office are also requested to issue formal orders for grant of the Ist/IIrd ACP/ Ist/IIrd/IIIrd MACP in respect of the above mentioned officials working in their Office. However, before the issuance of the formal orders, the Heads of office may again insure that these officials have completed 12/24 & 10/20/30 years of regular service since the date of their initial appointment in the service and are clear from vigilance angle.
